Agenda Item #3: Second Reading Ordinance 24-13: AN ORDINANCE AMENDING CHAPTER 180 OF THE CODE OF ORDINANCES OF THE TOWN OF FRISCO, CONCERNING THE UNIFIED DEVELOPMENT CODE, BY AMENDING SECTION 180-6.17, CONCERNING REFUSE MANAGEMENT AND SCREENING REQUIREMENTS FOR MULTIFAMILY RESIDENTIAL, MIXED-USE, AND NON-RESIDENTIAL DEVELOPMENTS WHICH HAD BEEN CONSTRUCTED AND RECEIVED CERTIFICATE OF OCCUPANCIES ON OR BEFORE MARCH 22, 2022

Mayor Ihnken read the item into the record and opened the Public Hearing at 7:19PM.

Community Development Director Katie Kent presented the item and noted that there were no changes to the Ordinance since First Reading. She did mention public comment received that was in Council's Materials Packet for this meeting *since* the First Reading, and offered to answer any questions.

Councilmember Held mentioned he has not personally experienced wildlife disturbances in his Timberline Disposal-supplied recycling totes.

Councilmember Kibbie asked if this only applies to multi-family or single-family residences. Katie responded that this Code Change applies only to multi-family residences.

Councilmember Held asked if enforcement of this Code Change falls on the Town, and

recommended we educate commercial refuse providers of this Change. Councilmembers Kibbie and Skrzypczak-Adrian also commented.

Katie clarified that single-family refuse container requirements do not fall under Chapter 180 of Town Code.

Mayor Ihnken recommended that Town facilities look into complying with this proposed Ordinance to set a good example.

Mayor Ihnken opened up Public Comment, seeing none, moved into Council Discussion at 7:22PM.


