FIRST AMENDMENT TO

INTERGOVERNMENTAL AGREEMENT FOR WATER SERVICES

THIS FIRST AMENDMENT TO INTERGOVERNMENTAL AGREEMENT FOR WATER SERVICES ("First Amendment") is entered into this 9th day of JANUARY, 2018 between the Town of Frisco, Colorado, a Colorado home rule municipality ("Town") and the Board of County Commissioners of Summit County, Colorado, a political subdivision of the State of Colorado ("County").

WHEREAS, the Town and County entered into an Intergovernmental Agreement for Water Services dated September 24, 2001 ("Agreement") providing for the Town's sale of treated water to the County for use at the County Commons; and

WHEREAS, the parties desire to amend the Agreement to authorize the sale of up to an additional one hundred thirty three and one-third (133.33) EQRs of treated water to the County in accordance with the terms of the Agreement, with the corresponding amount of raw water reserved for the benefit of Frisco in the Clinton Ditch and Reservoir Company being forty (40) additional Reserved Shares, as defined in the Agreement, with the actual amounts of treated water and reserved raw water to be determined by the final square footages of the new facilities.


NOW THEREFORE, it is agreed as follows:

1. The term "171.64 EQRs" as used in Section 2, Section 4 and Section 11 of the Agreement shall be amended to read as "304.97 EQRs".
2. The term "fifty two (52)" as used in Section 4 of the Agreement shall be amended to read as "ninety two (92)".
3. Except as expressly amended herein, all terms and conditions of the Agreement shall remain in full force and effect. The terms defined in the Agreement are incorporated herein by reference.
