ORDINANCE 24-09

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE TOWN OF FRISCO, COLORADO, BY AMENDING CHAPTER 53, CONCERNING ALCOHOLIC BEVERAGES, BY AMENDING SECTIONS 53-2, CONCERNING THE TOWN'S LIQUOR LICENSING AUTHORITY; 53-11, CONCERNING THE ISSUANCE OF LIQUOR LICENSES, AND 53-12, CONCERNING LICENSE RENEWALS, EACH TO MAKE THE TERMS OF THE LIQUOR LICENSES ISSUED BY THE TOWN CONSISTENT WITH THE 2-YEAR TERM FOR LIQUOR LICENSES RECENTLY ADOPTED BY THE STATE OF COLORADO.

WHEREAS, in its 2024 session, the State of Colorado's legislature amended the state's liquor licensing statutes to provide for a 2-year term for liquor licenses; and

WHEREAS, for ease of administration on the part of licensees, the Town, and the Town's local licensing authority, the Town Council has determined that the term of the Town's liquor licenses should coincide with the term of the liquor license that are authorized by the state licensing authority from time to time.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FRISCO, COLORADO:

Section 1. That Subsection 53-2.C.1.b. of the Code of Ordinances of the Town of Frisco, Colorado ("Code"), concerning the administrative renewal of liquor licenses, is hereby amended to read as follows:

b. The applicant's license is in good standing with the Town and State, and no violation of law has occurred during the most recent term of the license; ~~previous year~~

Section 2. That Subsection 53-11.A of the Code, concerning the issuance of liquor licenses, is hereby amended to read as follows:

A. All licenses applied for shall be issued in accordance with the laws of the State of Colorado and the Town of Frisco ~~and shall not be issued until it has been established that~~ ,and each Town license shall expire at the same time that the concurrent license issued by the State expires, and no Town license shall be issued until it has been established that:

Section 3. That Subsection 53-12.B of the Code, concerning the renewal liquor licenses, is hereby amended to read as follows:

- B. Upon receiving the renewal application, the Town Clerk shall assemble the file of the applicant, which file shall contain all of the various town departments' records regarding the applicant and the premises dating back for a period of at least ~~one year~~ two years. Unless there is evidence to the contrary, whether contained in the applicant's file or otherwise, it will be presumed that the occupied premises comply with the provisions of the applicable statutes and regulations, that the character of the applicant continues to be satisfactory and that such license, if granted, continues to meet the reasonable requirements of the neighborhood and the desires of the inhabitants. If these presumptions apply, the application may be administratively approved by the Town Clerk pursuant to Section 53-2 above or, if not so approved, shall be presented to the authority for public hearing.

Section 4. Severability, Conflicting Ordinances Repealed. If any section, subsection or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections and clauses shall not be affected thereby. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 5. Effective Date. This ordinance shall take effect pursuant to the Home Rule Charter of the Town of Frisco, Colorado.
