Town Council discussed policies that would reduce the use of single-use materials ahead of the upcoming state requirements within the Plastic Pollution Reduction Act, which in 2021 banned the use of single-use plastic bags by retailers, and after January 1, 2024, will ban polystyrene as a to-go container for certain restaurants after January 1, 2024. Council discussion centered on how to facilitate any potential changes with businesses and directed staff to research how other municipalities implemented single-use materials bans. Council plans to continue this discussion and gave staff the direction to focus on eliminating the distribution of single-use plastic water bottles in Frisco. Council also supported adding the requirement for businesses to "skip the stuff" such as plastic cutlery for takeout orders unless a customer specifically asks for it.
