Agenda Item #2: First Reading Ordinance 23-17: An Ordinance Amending Chapter 53 Of The Code Of Ordinances Of The Town Of Frisco, Colorado, Concerning Alcoholic Beverages, By Amending Section 53-2, Concerning The Licensing Authority And Its Assistant, To Provide For The Delegation Of Authority To The Town Clerk For Approval Of Certain Liquor Licensing Matters

Item introduced and public hearing opened by Mayor Mortensen at 7:35PM.

Town Clerk Stacey Nell provided legislative and chorological background and justification of why this Code change is needed, and helpful to a Frisco liquor licensee in a unique circumstance. The passing of SB18-243 forced a change to Fermented Malt Beverage liquor license holders, and Shelbees Gas & Convenience LLC located in Frisco has applied to change their class in license, per State process requirements, to change their class in license to "Fermented Malt Beverage and Wine" so they can carry wine. The Fermented Malt Beverage and Wine license was recently created by the passage of Proposition 125 on the November 2022 General Election ballot in Colorado.

Agenda Item #3: First Reading Ordinance 23-14: An Ordinance Concerning The Development Of Two Affordable Rental Housing Projects, And In Connection Therewith, Authorizing (I) A Long Term Ground Lease Of Certain Real Property Owned By The Town And Known As 602 Galena Street, And (II) A Loan By The Town To The Developer To Aid In The Acquisition Of Certain Other Real Property Known As 101 West Main Street, All In Accordance With The Development Agreement Between The Town Of Frisco And The NHP Foundation, Dated As Of May 23, 2023

Item introduced and public hearing opened by Mayor Mortensen at 7:38PM.

Town Attorney Thad Renaud provided background information. The Town owns 602 Galena Street, and has intent to develop the property for workforce housing. NHP Foundation approached the Town to assist in the development of the project, and provided legal context for the drafting of the agreement that facilitates a legal relationship to develop a LITECH project, between the Town and this non-profit entity.

Town Manager Tom Fisher provided interest percentages information.

Councilmember Skrzypczak-Adrian asked Mr. Renaud about financing processing and the possibility of a childcare component. Councilmember Burley asked a similar question about mixed use.

Mr. Renaud and Mr. Fisher responded that there is a percentage requirement for mixed use, and the Town is seeking to transfer some office space requirements to a different project.

Mayor Pro Tem Ihnken and Councilmember Held commented in support of the project to move forward.

Councilmember Aerenson commented in support of subsidizing project developments for housing, as opposed to developing and owning projects permanently. He praised the work on the legal documents provided by Attorneys John Petersen and Thad Renaud in the Council packet.

Public comment opened by Mayor Mortensen at 7:51PM, seeing none, closed at 7:51PM.

Public Works Director Jeff Goble reiterated that this Ordinance has not been amended, and offered assistance should any Councilmembers have any clarification needs. Mr. Goble briefly summarized the chronological order of how the item came before Council this evening.

Mayor Mortensen praised Mr. Goble's passion and efforts toward water rights and water administration.

Councilmember Aerenson commented that this process is a beginning, not the end of water supply control, and applies a process to do so.
