Agenda #3: RESOLUTION 23-26: 2024 LEGISLATIVE POLICY STATEMENT ADOPTION

Town Clerk Stacey Nell presented the Proposed 2024 Legislative Policy Statement and Resolution, providing background on the formation of the document, direction that has been folded into the document from the September 26, 2023 Town Council Work Session. Finance Director Leslie Edwards added that this document will be very helpful for her role on the Colorado Municipal League (CML) Policy Committee, and that this document will truly be used and put into action.
