RESOLUTION 21-06**

A RESOLUTION FOR THE PURCHASE OF NEW PONTOONS BOATS AND MOTORS FROM CROWLEY MARINE FOR THE FRISCO BAY MARINA.

WHEREAS, the Town Council supports Frisco's economy by recognizing, preserving, and improving upon the assets that sustain our community, including Frisco's iconic Main Street; the commercial core on and around Summit Boulevard; and the outstanding recreational opportunities at the Frisco Bay Marina, Dillon Reservoir, local parks, Frisco Adventure Park, Frisco Nordic Center, and the public lands surrounding Frisco; and

WHEREAS, in connection with the support of Frisco's economy and maintenance and improvement of Town assets, it is in the Town's best interest, and aligns with the Thriving Economy section of the Towns Strategic Plan, for the Town's Marina to replace aging rental boats; and

WHEREAS, the Frisco Bay Marina (the "Marina") desires to purchase six new Sylvan pontoon boats and six Yamaha outboard motors that will replace aging boats in the rental boat fleet; and

WHEREAS, pursuant to Chapter 9 of the Code of Ordinances of the Town of Frisco, Town staff released a Request for Proposals (RFP) for the Purchase of Six (6) New Pontoon Boats and Motors, with proposals from qualified firms due on February 8 2021; and

WHEREAS, the Town of Frisco received two (2) bids, on or before February 8, 2021; and

WHEREAS, the Town Council has determined that the staff recommendation for the identified purchase will provide the best value to the Town; and

WHEREAS, as a result of the quality, service, and price outlined in the proposal provided by Crowley Marine, the Town Council awards the Pontoon Boat Purchase to Crowley Marine; and

WHEREAS, the Town Council finds that the price set forth by Crowley Marine is fair and reasonable, relative to the general market prices for the goods and services to be provided by Crowley Marine.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FRISCO THAT:

The Mayor and Town Clerk are hereby authorized to execute any and all documents necessary to effectuate the purchase of six (6) pontoon boats and motors from Crowley Marine for a total cost not to exceed \$180,000 (one-hundred eighty thousand dollars).
