

Q1 Are you completing this survey as:





Q2 What type of short-term rental property do you own/manage?





Q3 How many bedrooms does this property have?







Q5 What time of year does the owner use this property?





Q6 Is this property currently rented to short-term or long-term renters?





Q7 Has the owner ever rented this property to long-term renters?






