TOWN OF FRISCO COUNTY OF SUMMIT STATE OF COLORADO RESOLUTION

A RESOLUTION TO ESTABLISH A SPECIAL EVENT PET POLICY TO DESIGNATE WHICH 2022 TOWN OF FRISCO SPECIAL EVENTS WILL PROHIBIT PETS WITHIN EVENT VENUES.

WHEREAS, the Town Council wants to inform citizens and visitors, in the interest of their safety and the safety of their pets, which Town events do not allow pets; and

WHEREAS, the Town Council emphasizes that dogs assisting handicapped persons will be allowed at all Town special events, even those prohibiting pets; and

WHEREAS, the Town Council has directed the Police Department staff on which events will prohibit pets within the event venues; and

WHEREAS, the Police Department will enforce the event pet policies by issuing warnings, asking patrons with pets to leave the premises when pets are prohibited and issuing citations for repeat offenders;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FRISCO, COLORADO, THAT:

THE FOLLOWING 2022 TOWN SPECIAL EVENTS WILL **NOT** ALLOW PETS:

- Frisco Nordic Center Races and Events Up and At Em' Nordic Races (January 5, 2022, January 19, 2022, February 5, 2022 & February 23, 2022), Frisco Gold Rush (February 12, 2022), Frisco Freeze (February 19, 2022), Eat, Ski & Be Merry (February 26, 2022), Snowshoe for the Cure (March 5, 2022) and Frisco BrewSki (March 12, 2022)
- Colorado Barbecue Challenge June 16-18, 2022
- Bacon Burner 6k June 18, 2022
- Mountain Goat Kids' Trail Running Series- June 14, June 28, July 12 and July 26, 2022 (not allowed in the race, but allowed at the start and finish)
- Frisco Triathlon July 8, 2022 (not allowed in the race, but allowed at the start and finish)
- Run the Rockies Trail Race August 13, 2022 (not allowed in the race, but allowed at the start and finish)
- Run the Rockies Road Race September 17, 2022 (not allowed in the race, but allowed at the start and finish)

At this time, all other 2022 Town of Frisco special events will allow pets on leashes as long as they are under control by an attending person at all times.
