A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE TOWN OF BRECKENRIDGE FOR THE ADMINISTRATION OF A CHILDCARE TUITION ASSISTANCE PROGRAM

WHEREAS, governmental entities are authorized by Article XIV of the Colorado Constitution and Part 2 of Article 1 of Title 29, C.R.S., to co-operate and contract with one another to provide any function, service, or facility lawfully authorized to each of the Cooperating or contracting governmental entities; and

WHEREAS, the Town of Breckenridge ("Breckenridge") and the Town of Frisco ("Frisco") are both home rule municipal corporations organized and existing under Article XX of the Colorado Constitution; and

WHEREAS, rate increases are anticipated at local childcare facilities in order for the centers to generate sufficient revenue to cover expenses and become financially self-sustaining; and

WHEREAS, many local working households are unable to afford the true cost of childcare; and

WHEREAS, the Town Council desires to support our local economy by increasing access to safe, affordable, quality childcare for working parents/guardians; and

WHEREAS, a childcare tuition assistance program will better enable the Town of Frisco to retain the character of our community by enabling local households to live, work, and raise their children in the community; and

WHEREAS, Breckenridge currently administers a childcare tuition assistance program; and

WHEREAS, Breckenridge and Frisco have agreed upon various matters related to the administration of a child-care tuition assistance program, all as more fully set forth in a proposed Intergovernmental Agreement, a copy of which is marked Exhibit "A", attached hereto, and incorporated herein by reference; and

WHEREAS, it is the intent and purpose of the proposed Intergovernmental Agreement to establish a framework for Breckenridge and Frisco to provide information and details regarding the logistics and operations of their joint childcare efforts; and

WHEREAS, the Town Council has reviewed the proposed Intergovernmental Agreement, and finds and determines that it would be in the best interest of the Town to enter into such Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FRISCO, COLORADO, as follows:

<u>Section 1</u>. The proposed "Intergovernmental Agreement for the Administration of a Childcare Tuition Assistance Program" with the Town of Breckenridge (Exhibit "A" hereto) is approved, and the Mayor is authorized, empowered, and directed to approve such an agreement for and on behalf of the Town of Frisco.

<u>Section 2</u>. This resolution is effective upon adoption.
