**RE: SECOND READING – ORDINANCE 22-15**  
**DATE: DECEMBER 13, 2022**

**Summary and Background:** Per the Town of Frisco Home Rule Charter, every five years, each Chapter of the Frisco Town Code is to be reviewed for possible amendment or repeal. Scheduled for review at this time is Chapter 140.

The Town of Frisco adopted Chapter 140 of the Code of Ordinances of the Town of Frisco, Colorado, concerning the Dillon Reservoir Recreation Area into the Frisco Town Code by Ordinance 02-23 on October 15, 2002. The rules and regulations were recently amended in 2021 by the interagency Dillon Reservoir Recreation Committee (DRReC), and approved by the Board of County Commissioners on September 14, 2021.

Staff has reviewed Chapter 140 and recommends amendments to eight (8) sections to match the amended changes from DRReC. These amendments were reviewed and approved by Council on first reading of Ordinance 22-15 on November 8, 2022. Second reading of Ordinance 22-15 is before Council at this time.

**Analysis:** DRReC meets monthly, and the voting member on this committee for the Town of Frisco is Logan Snyder, General Manager of the Frisco Bay Marina. The rules and regulations for lands and waters within the Dillon Reservoir Recreation Area were reviewed and updated by the committee in 2021. Changes to sections 140-1, 140-3, 140-4, 140-15, 140-18, 140-19, 140-21, and 140-30 of Chapter 140 of the Code of Ordinance of the Town of Frisco, Colorado, are detailed in the attached Ordinance 22-15, were reviewed by staff at the November 8, 2022, Council meeting, and will be reviewed by staff for second reading on December 13, 2022.

**Financial Impact:** n/a

**Alignment with Strategic Plan:** The Town of Frisco recognizes recreational, historical, artistic, and cultural assets and experiences as foundational to the Town's vibrancy and the quality of life for residents and visitors. Furthermore, the Town commits to providing unique and accessible opportunities for residents and visitors. The Frisco Bay Marina and the Dillon

Reservoir are instrumental in providing these unique and accessible opportunities. Changes to the Code of Ordinances of the Town of Frisco, Colorado, concerning the Dillon Reservoir Recreation Area support ongoing operational improvements to the Dillon Reservoir as a whole.

**Staff Recommendation:** Staff recommends that Council approve on second reading Ordinance 22- 15, an ordinance amending chapter 140 of the code of ordinances of the Town of Frisco, Colorado, concerning the Dillon Reservoir Recreation Area, by amending sections 140-1, concerning definitions; 140-3, concerning fires and fireworks; 140-4, concerning motorized vehicles and snowmobiles; 140-15, concerning water contact activities; 140-18, concerning prohibited water craft; 140-19, concerning boat launches; 140-21, concerning special event permits; and 140-30, concerning violations and penalties.
