RE: RESOLUTION 23-17: CONTRACT AWARD FOR 2023 BRIDGE WORK PROJECT TO MYERS & SONS CONSTRUCTION.
DATE: APRIL 11, 2023

Summary and Background: Every two years the Colorado Department of Transportation (CDOT), through its engineering consultant, inspects all four off-system roadway bridges within the Town. These inspections are done at no cost to the Town. The last inspection performed was in 2021 and this inspection noted some deficiencies that need to be rectified on each of the four roadway bridges. These bridges are located on West Main St., Creekside Dr, Madison Ave., and 4th Ave. The 2023 Bridge Work Project will focus on the West Main St. and the 4th Ave bridges. There will be another inspection this year and we will use those results to determine what needs to be done on the two other bridges and budget for that work in 2024.

Analysis: After review of the inspection results, staff determined that this years project needs to concentrate on the West Main St. and 4th Ave. bridges as they received lower scores during the inspection. The work to be performed on the West Main St. bridge includes; traffic control as needed, raising the approach rail, raising the bridge rail, and seal the asphalt cracking and raveling on the abutments. Public Works staff will also perform some work to repair and prevent scouring of the abutment bases within the creek bed.

The work to be performed on the 4th Ave. bridge includes; traffic control as needed, install a double-nested flex beam on the south east rail transition and remove and replace the chip seal at the peeled locations on the bridge deck. Public Works staff will also perform some work to repair and prevent scouring of the abutment bases within the creek bed.

Financial Impact: The Town went out to bid for this project in November 2022 and received only one proposal in December 2023, from Myers & Sons Construction, LLC in the amount of \$260,593.80. The funding for this project will come from the General Fund – Public Works – Streets Division – Road Repair & Maintenance line item (10-1131-4403) which has \$310,400.00 budgeted for 2023.

Alignment with Strategic Plan: This project aligns with the Quality Core Services section of the Strategic plan by ensuring the preservation, continued operation and safety of a very critical roadway infrastructure asset that these bridges represent.

Environmental Sustainability: This section not Applicable to this project.

Staff Recommendation: Staff recommends that Council approve Resolution 23-17 and authorize the Town to enter into a contract with Myers & Sons Construction, LLC for the 2023 Bridge Work project at an amount not to exceed \$260,593.80
